

- 1. It is submitted by learned counsel for the petitioners that the action of the respondents in issuing the notification seeking applications for Mahatma Gandhi Sewa Prerak (Annex.3) is exfacie contrary to the settled principles governing public employment.
- 2. Submissions have been made that the scheme does not provides for any criteria for determining the inter se merit of the candidates.
- 3. Further submissions have been made that preference, interalia, has been indicated to those holding certificate of having participated in Mahatma Gandhi Darshan Prashikshan Shivir, which is a one day camp organized, wherein few lectures are delivered, which cannot be made a basis for providing preference.
- 4. Allegations have been made that the said Scheme has been floated / criteria has been adopted only with a view to dole out Rs.4,500/- per month to the blue eyed persons of the administration and therefore, the Scheme itself is bad. It is also alleged that earlier a Scheme for appointment of Preraks was



floated, which continued till the year 2018, wherein the petitioners have worked and in fact, they have performed similar nature of work, however, in the notification issued, no preference / bonus marks has been provided based on their experience, which also reflects on the malafide nature of the Scheme prepared and floated.

- 5. In view of the submissions made, issue notice. Issue notice of stay application also. Both are made returnable on 19.10.2023.
- 6. In the meanwhile and till further orders, the respondents may proceed pursuant to the Notification dated 13.08.2023 (Annex.2), however, they shall not provide appointment / engagement to any person.
